TEMPORARY MEMBERSHIP RULE – 7.9.3

Any person may be admitted to Temporary Membership upon the recommendation of the General Manager or a General Committee Member specifically authorised for this purpose. A properly completed application form for Membership in a category other than Temporary Membership must be submitted. The member shall be liable in respect of the period of Temporary membership for a subscription pro rata of the Annual subscription of the category to which he has been elected for each month of Temporary Membership.

NOTE: TEMPORARY MEMBERSHIP is not renewable and is on the understanding that an application for FULL MEMBERSHIP is applied for in October

3. Any craft or gear whether, at its moorings, being handled, stored, repaired or maintained are at owners' risk and this Rule shall be binding upon all members and visitors.
