### Notice of Race

## Winter Dinghy Open Series Sunday 5<sup>th</sup> Oct to Sunday 21st Dec 2008

Racing will take place in Poole Harbour.

**Rules:** The Series will be governed by The Racing Rules of Sailing 2005 – 2008 (RRS), RYA Prescriptions, Class Rules, Parkstone Y.C. Course Book & Sailing Instructions 2005 Edition (SI's) and this Notice of Race. Boats are allowed to advertise as per category C as detailed in RRS Appendix 1 unless the appropriate Class Rules classify them as category A.

**Eligibility:** This is an Open Event for the classes listed below. Entrants should be members of an RYA affiliated club or members of the RYA.

**Liability:** Attention is drawn to the LIABILITY conditions on the Entry Form which must be accepted by each entry. Competing boats must be insured for a minimum of £2,000,000 Third Party Liability.

**Registration:** All competitors must pay their entry fee and register with the club office by 0930hrs 5th Oct 2008.

**Sailing Instructions:** Adult visitors should obtain a copy of the SI's at registration. The Youth Fleets will be on a separate Committee Boat start line and they will have their own SI's and courses and can be obtained from the Youth representative.

**Entry Fee:** A schedule of charges for both members and visitors is attached. Competitors paying for optional winter storage must remove their boats by 2nd January, 2009.

**Personal Buoyancy:** All competitors shall wear personal buoyancy whilst afloat. Wet suits and dry suits do not constitute adequate personal buoyancy. This modifies RRS 40 & SI 3.

**Starting Procedure:** Each fleet will have a 5 minute start sequence.

The start sequence may be amended if any class has a significant amount of entries

**Scoring:** As per SI 11, each class is responsible for its own points & series scoring.

**Prizes:** Each class is responsible for awarding class trophies where applicable.

**Catering:** Meals will be available in the club house each Sunday after racing.

**Boat Storage:** Space in the yard will be limited. Spaces will be allocated on a 'first come' basis with priority being given to the classes that are difficult to trail sail. Storage is subject to boats sailing in at least 50% of the races held.

Boats being stored in the yard must display a valid sticker which can be obtained, having first registered, from the Haven Office from 0900 to 1200 on 5<sup>th</sup> Oct 2008.

Boats must be removed from the yard by 2nd January 2009

**Temporary Membership:** Visiting competitors must pay the race entry fee and the visitors supplement, they then become Temporary Members of Parkstone Yacht Club for the duration of the series. Any non-competing visitors must be 'signed in' as a guest by a Full Member of the club. Visitors' children under the age of 16yrs must be accompanied by a parent/guardian at all times whilst on club premises.

Temporary members may purchase a 'Clubcard' from the main office for a refundable £10 deposit to allow them access into the Clubhouse, Yard and Gents Changing Room.

**Single Race Entry** fee is £8.00 and individual forms are available from the sailing office and must be completed and return to the main office with full payment BEFORE going afloat. This can only be used to a maximum of seven times and does not include boat storage.

Further, in the event that assistance is rendered to any competitor, no liability for any loss damage or injury to the competitor and or the boat and its equipment is accepted by either the Club or the crew of such rescue craft.

3. RRS Rule 4. **'DECISION TO RACE.** The responsibility for a boat's decision to participate in a race or to continue *racing* is hers alone'

4. Insurance will be maintained at all times on the above boat to a minimum third party liability of £2,000,000.

5. At all times, the above boat will comply with all Class Rules including buoyancy and safety provisions.

6. I CERTIFY THAT I AM 18 YEARS OR MORE IN AGE AND I WILL NOT PERMIT ANYONE UNDER THE AGE OF 18 YEARS TO HAVE COMMAND OF THE BOAT UNLESS PARAGRAPH 7 OF THIS FORM IS COUNTER-SIGNED AND THAT SUCH FORM HAS BEEN COMPLETED AND RETURNED AT THE CLUB OFFICE.
